Confirmation & Cancellation Policy

Registration

A completed application form, a copy of the NRIC or work pass (for foreigners) (both sides) and highest academic certificate with the course fee are to be submitted earlier by hand to **CBLD Center**.

Confirmation

Payment by cash (for individuals) or SkillsFuture Credit (for Singaporeans), cheque or Giro Bank Transfer (for Companies) must be made at least 2 weeks before the commencement of the course. Upon receipt of full payment of course fee, a confirmation of enrolment will be sent.

Participant who is a Singapore Citizen or Singapore Permanent Resident will be eligible for the funding by SSG only on successful completion of each module which includes :

a) Having attained at least 75% attendance for training and **b)** Having attended and completed the assessment successfully. If these are not met, participant or his/her company (if he/she is sponsored by the company) will have to reimburse CBLD Center the full course fee before funding including GST. CBLD Center reserves the right to cancel or reschedule the class. All efforts will be made to inform participants who have signed up soonest possible.
